As we reflect on 2013, The Ivy Community Charities of Prince George's County, Inc. (Charities) is dedicated to our mission of service, strongly committed to our community and sincerely thankful for our generous supporters. As President and Executive Director of Charities, we are pleased to share the organization's tremendous accomplishments in this *2013 Annual Report*. This report summarizes our overall operations, highlights the tremendous breadth of our programs and services, outlines our financial status, and features a listing of our generous contributors.

Since 1986, Charities has proudly served the Prince George's County community. Over those 27 years, Charities has made several significant achievements, won a host of community service awards and attained county recognition. We purchased property in Suitland without a mortgage to establish the Ivy Youth and Family Center where we conduct our community service activities, house our administrative offices, and host organizational meetings for our members and the community. Over the past 12 months, we received more than \$500,000 in State and county grants and more than \$100,000 in donations to establish four scholarship endowment funds. Our balance sheet documents our net worth at approximately three-quarters of a million dollars including real estate, personal property, investments and cash assets. The Prince George's County Council honored us along with 11 other Prince George's County nonprofits during Nonprofit Awareness Week and we completed the necessary documentation to be recognized as a Maryland Nonprofits Standards for Excellence Tier One organization.

Our commitment to service is the core of our mission. In 2013, we awarded over \$40,000 in scholarships to high school seniors; tutored and mentored over 100 students in elementary, middle and high school; created clothes closets to serve hundreds of residents looking for work; prepared hundreds of food baskets for our adopted families and local residents; provided hundreds of pairs of socks and shoes to youth; supported and cared for our senior residents; provided over 500 backpacks filled with school supplies; and contributed significant funds and resources to various health organizations. As you will see throughout this report, we understand that giving back is the key to making a significant and positive change in our community.

Charities is far stronger now in our performance and the impact we are making. We have employed strategies that have the greatest impact, strengthened our operations through solid financial oversight, and evaluated our programs to increase our effectiveness thus creating an indelible footprint in the community. We owe this in large part to our generous supporters and community partners. Your overwhelming support and generosity has allowed Charities to become a premiere non-profit and to continue to offer much needed service to our neighbors.

However, we will not rest on our laurels. Charities is poised to increase what we do by the mere fact that we are now more firmly rooted in the community through our Ivy Youth and Family Center. In 2014 and beyond, we will focus our priorities on increased monitoring of the impact and progress of our programs, expanding our fundraising efforts, strengthening relationships with our community partners, and engaging in more corporate and organizational partnerships.

We are, along with the members of Charities, committed to our mission and working harder to maximize our efforts in helping to improve the lives of the citizens of Prince George's County. We have been honored and proud to work with such an outstanding Board of Directors, dedicated members, and generous community partners. Thanks to all of you, it was a remarkable year for Charities.

And, just as important as where we have been is where we are going. We look forward to a bright future for the organization guided by our incoming President, Saran Baker and a committed, resourceful, and forward-thinking Board of Directors.

Once again, we thank you for your steadfast commitment of Charities and the work we do. We will continue to serve with open hearts, strong minds and giving spirits as we impact future generations by keeping our doors open to serve the community.

## Tutoring and Mentoring Youth: The Ivy League

*A comprehensive social service program for youth and families*

### Elementary School

At the Popcorn Club, reading is both fun and fundamental. Our volunteers provide a fun environment where students receive help after school with reading, mathematics, science and social studies as well as homework assignments. During 2013, the program was held at Longfields Elementary School in Forestville, Maryland. In one of the segments that we called "Math Meets Nutrition," the students were given an orange and told to make a centerpiece by attaching a variety of fruits and vegetables to the orange using a toothpick. On another occasion, the students were divided into two sports teams for a multiplication competition. We found that using hands-on activities helps to enforce concepts presented during the school day. As a result of our efforts, Charities and the Alpha Kappa Alpha Sorority, Inc., Iota Gamma Omega Chapter received the 2013 Partner of the Year Award from the school.



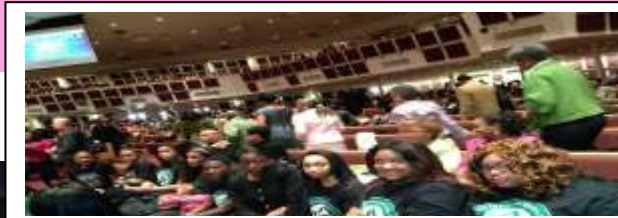
### Middle School

The Emerging Young Leaders (EYL)/Sarah Wise Wooten Young Ladies Program encourages positive self-esteem, leadership skills and community service among middle school girls. Workshops, field outings and service projects are held monthly throughout the school year. During 2013, the participants attended the Youth Empowerment Summit hosted by County Council Member Ingrid M. Turner; created turkey wreaths and packed Thanksgiving baskets for needy families; learned critical techniques for test-taking and study skills; discussed the factors for developing positive self-esteem; collected, sorted, packed and delivered donations to local homeless shelters in celebration of the Martin Luther King Day of Service; weeded and planted a garden at the Ivy Youth and Family Center; and learned to cook healthy meals along with proper dining etiquette and table setting. The 2012-2013 school year ended with a trip to Hershey Park along with the GADAAY students.



### High School

The Institute for the Growth and Development of All of America's Youth (Institute GADAAY) promotes the personal, social and cultural growth and development of high school students. The monthly workshops, field experiences and service activities prepare the students for college and careers. During 2013 activities included topics on financial literacy, setting goals and timetables, social media pitfalls, and understanding teenage relationships; a college tour to Howard University and Hampton University; a city tour to New York City; and preparation and delivery of fruit baskets for 150 senior citizens.



### Parents

The Parents on Track initiative provides workshops and resources for parents, whose involvement is critical to the success of our student programs. The parents meet monthly during the same time that their students participate in our youth programs. The interactive sessions allow the parents to share their experiences, concerns and techniques, thereby establishing a support network to empower parents as agents of change.



## Awarding Scholarly Achievement

Charities provided more than \$400,000.00 in scholarships to more than 350 Prince George's County students on the basis of academic excellence or financial need since 1994. During our Ivy League Awards program in June 2013, we awarded scholarships to 17 high school seniors totaling more than \$40,000.00 including ten \$3,000.00 scholarships. We were honored to be the recipients of grant awards from County Council Members Ingrid M. Turner (District 4), Derrick Leon Davis (District 5), Karen R. Toles (District 7), Obie Patterson (District 8) and Mel Franklin (District 9) that allowed us to increase our scholarship award amounts and numbers of scholarship recipients. Two college students received scholarships to continue at their respective institutions as a result of the generous contributions from Dr. Frances Plummer and the Clarke Family. One scholarship was awarded in memory of Angela Holland, a young woman and member of Charities who passed away in 2012.

Charities established two scholarship endowment funds in 2013, bringing our total number of endowment funds to four. The family of June C. Turner requested the establishment of a scholarship endowment in her name upon her death in 2013. We received a sizeable donation from the Trust of the Late Mary Ray Thompson, our first Executive Director who passed away in 2011 and established a scholarship endowment in her memory upon receipt of the donation in 2013. Donations to each of these funds exceeded \$20,000.00 and they were capitalized upon their establishment. Scholarships will be made in recognition of these former members in 2014.

Charities established its first scholarship endowment in 2010 –the District Four Scholarship Endowment Fund - awarded to Charities by Council Member Ingrid M. Turner. The Fund has been capitalized and the first scholarship through the Fund will also be made in 2014.



## Encouraging Healthy Lifestyles

Our 18<sup>th</sup> Annual 5K Walk/Run/Dance for the Health of It continued to be our most successful fundraiser and event to encourage healthy living. Through this effort, we announced our contribution of \$750.00 each to four health organizations for a total of \$3,000.00 to promote community awareness and public support of health issues that especially affect women and the African American community. During 2013, we also continued our partnership with the Largo Community Church by supporting the Largo **Community Health Fair**. Several of our members who are health professionals assisted with health assessments, presentations and the distribution of resource materials. More than 200 persons attended each of these community events.



## Serving Families and the Elderly

For the past 20 years, Charities has partnered with the Prince George's County Department of Social Services to provide financial support for families in need. In 2013, Charities supported six **Adopted Families** with clothing, shoes, school supplies, and food during the holidays and throughout the year.

Our service to the community began in 1986 and Charities shared Iota Gamma Omega's commitment to families that began in the 1970's by supporting the **Shoe Bank** project that provides new shoes for youth of all ages. In 2013, Charities spent nearly \$1,100.00 to purchase shoes for children. In addition to our Adopted Families, in 2013 we partnered with the Suitland Action Team and provided shoes to families residing at a local domestic violence shelter in Suitland.

We responded to the call to service solicited by President and Mrs. Barack Obama by commemorating the **Martin Luther King, Jr., Day of Service** with a two-day program of community service beginning with a Sunday Supper for 200 youth and families. On Monday, we sorted, packed and delivered food to four area shelters and military families at Andrews Air Force Base in Camp Springs, Maryland. Our efforts, which were held in collaboration with the Alpha Kappa Alpha Sorority, Inc., Iota Gamma Omega, Upsilon Tau Omega, Psi Epsilon Omega and Eta Chapters were reported in the [Andrews Air Force Base Gazette](#).

Each year we fill backpacks with school supplies and donate them to Prince George's County schools. In 2013, we donated 99 backpacks to four elementary schools and the Shepherd's Cove Shelter for battered women and their families.

In addition to the Popcorn Club, we partnered with the Men of Tomorrow program at Longfields Elementary School by providing uniforms for 26 boys who participate in the program. The program is designed to help the young boys to become strong future leaders.

We partnered with the Melwood Center and the Alpha Kappa Alpha Sorority, Inc., Iota Gamma Omega Chapter to establish the First Impressions Clothes Closet. Our members, friends and community partners provided clothes, shoes and accessories for adults with special needs who were entering the workforce. We collected a total of 555 items including 488 items for women and 67 items for men.

Charities partnered with the Mall of Prince George's to offer Christmas gifts to the Angel Tree Project serving disadvantaged families. A total of 170 gifts were collected and delivered to Shepherd's Cove, Kingdom Village, the Family Crisis Center and children of incarcerated parents. With the financial donations for this effort, we provided each shelter with a gift card for \$80.00 from Wal-Mart.

The Ivy Youth and Family Center offers the ideal environment for a variety of family-friendly activities. Our Ivy Neighborhood Fun Days in 2013 included an Arbor Day spruce-up in the spring, an Easter Roll on the lawn with arts and crafts activities throughout the inside in April, and a Trunk and Treat Fun Night in October.

Through the **Sunshine Club**, our community outreach also targets senior citizens, many of whom laid the foundation that embodies the rich history and culture of Prince George's County. We supported the elderly with monthly visits to the Forestville Nursing and Rehabilitation Center where we engage the residents in games, birthday parties and other activities to stimulate their minds; we provided 150 Thanksgiving fruit baskets to the residents of the Windsor Crossing Senior Apartments; and we launched our Keeping Intercommunications among Seniors and Students (KISS) Program where the seniors teach our middle school girls to cook. Beginning in 2014, the girls will reciprocate and teach the elderly to use computers.





## Financial Highlights

Charities supports its activities through a variety of resources including membership dues, fundraisers, grants, bequests, endowment funds, online efforts, and federal charitable campaigns. In 2013, Charities conducted **three fundraisers** in collaboration with the Alpha Kappa Alpha Sorority, Inc., Iota Gamma Omega Chapter to support the organizations' joint programs of service.

- The 20<sup>th</sup> Annual Cotillion~Beautillion was held at LaFontaine Bleau in New Carrollton, Maryland, where nine young ladies and young men were presented to society.
- The Third Annual Prince George's County Men Can Cook was held at the Glenarden Municipal Center in Glenarden, Maryland and showcased the culinary talents of local chefs including County Council Member Derrick Leon Davis (District 6).
- The 18<sup>th</sup> Annual 5K Walk/Run/Dance for the Health of It was held at the Watkins Regional Park in Upper Marlboro, Maryland and provided an opportunity to participate in healthy exercise activities, attend a mini health fair, and receive valuable resources about healthy eating and living.



Charities also conducted fundraisers in support of the Ivy Youth and Family Center's capital campaign. In 2013, Charities hosted "A Caribbean Affair in White" at the Woodmore Country Club, featuring a bachelor and bachelorette auction as well as a brick rally campaign.

Charities successfully applied for and was awarded **grants** to support our programs of service, capital improvements and general operations including:

- Community Development Block Grant (CDBG) Program Year 39 to support our Ivy League Program
- Community Development Block Grant (CDBG) Program Year 39 Reprogrammed funds to support the capital improvements and renovations of the Ivy Youth and Family Center
- County Executive's Community Partnership Grant to cover expenses associated with the Ivy Youth and Family Center
- Special Appropriation Grants from Council Members Mary Lehman (District 1), Ingrid M. Turner (District 4), Derrick Leon Davis (District 6), Karen R. Toles (District 7), Obie Patterson (District 8) and Mel Franklin (District 9)
- Human Services Coalition scholarship to support our application for the Maryland Nonprofits Standards for Excellence® program

During 2013, Charities established scholarship **endowment funds** in memory of two of its beloved members:

- The family of Mrs. June C. Turner selected Charities to establish the June C. Turner Education Endowment Fund in May 2013. With the support of the family and Mrs. Turner's many friends and admirers, the Fund reached more than \$23,000.00 in the same year.
- In 2013, Charities received a \$50,000.00 gift from the Estate of Mrs. Mary Ray Thompson, our first Executive Director, who passed away in 2011. In honor of the generous donation, the Board of Directors established the Mary Ray Thompson Scholarship Endowment Fund which was capitalized in the same year. A portion of the funds were also used to support the Ivy Youth and Family Center, making Mrs. Thompson the largest single donor of the facility. The building's community room was also named in her honor.



These two special gifts bring the total number of endowments established by Charities to four. The District Four Scholarship Endowment was established by Council Member Ingrid M. Turner in 2010 and represents the largest endowment managed by our organization. The Ivy Community Charities Endowment Fund was established by our second Executive Director and Founding President, Erma W. Barron, in 2011. We humbly thank the donors and families who put their trust and confidence in Charities to allow us to establish these endowments to support Prince George's County students. The four funds represent more than \$100,000.00 in scholarship endowments.

For the first time since its inception, Charities participated in the **Combined Federal Campaign (CFC #30642)**. CFC is the world's largest and most successful annual workplace charity campaign raising millions of dollars each year. Pledges made by Federal civilian, postal and military donors during the campaign season support eligible non-profit organizations that provide health and human service benefits throughout the world.



Finally, we found the online giving campaigns to be a successful strategy for securing funding. In 2013, Charities participated in #GivingTuesday, a 24-hour e-giving opportunity that followed Good Friday and Cyber Monday. Tuesday, December 3<sup>rd</sup> was set as the date for Americans to celebrate the holiday season by donating online to their favorite nonprofit organizations and Charities was one of the hundreds of charitable organizations that benefited from the special event.

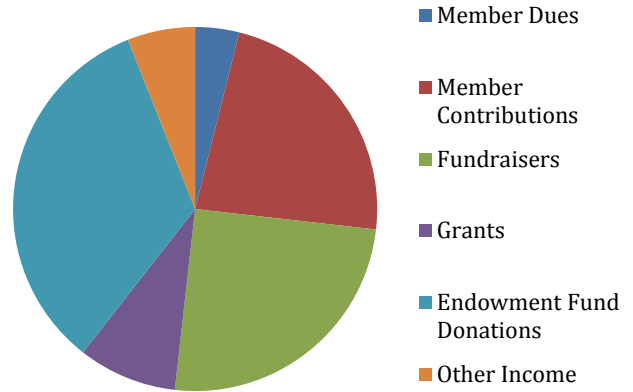

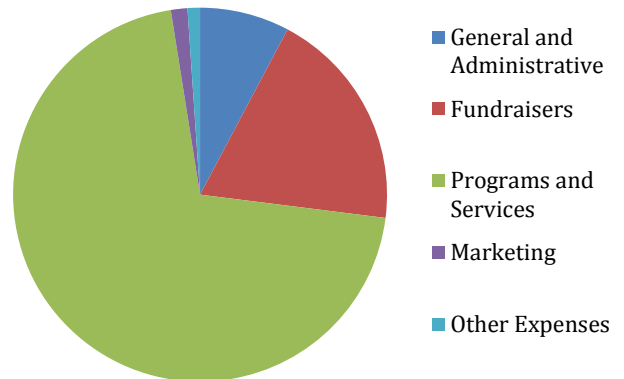
