

Every year we write about how amazing the previous year has been. Truly 2018 was no different. In fact, we surpassed nearly every goal for administrative, fundraising and programmatic efforts. We completed our second Strategic Plan that will help guide us to Charities' 35th year of service and beyond. We set a record for the number and amount of grants awarded to support programs and services, which exceeded \$100,000.00. Grant funds permitted us to provide nominal stipends to four stall positions beyond those included in Charities' annual budget. Addressing the Needs of Children and Youth

Elementary School Enrichment: The Popcorn Club is an after school program for elementary students to improve their reading and literacy skills and foster their understanding and participation in STEAM (science, technology, engineering, art and mathematics) subjects. In 2018, Charities continued its program at William Beanes Elementary School and expanded the program to include Forest Heights Elementary School as the result of a grant from the Prince George's County Local Development Council. A new offering at William Beanes Elementary School was the Pollination Education Program which was held in partnership with the Old Maryland Farm and the Maryland National Capital Park and Planning Commission. The program allowed us to educate 138 young people about the importance of pollinators in our agricultural and economic environment. The students were provided wildflower seeds to plant over 1,400 square feet of wildflower meadows in a pollinator habitat. These meadows can help stop the decline of bees, butterflies, and other pollinators. Students at Forest Heights learned to be Explorers in Aruba as they studied maps to understand the concept of distances and examined their own butterflies brought back from Aruba by Executive Director Cheryl Petty Garnette. Using technology, they identified online which state insects are butterflies and the names of the various state butteflies (the Baltimore Checkerspot Butterfly is the Maryland state insect!) In December, students from both schools were taken on field trips; the William Beanes students visited New York City to see the Rockettes Christmas Spectacular at Radio City Music Hall and the Forest Heights students enjoyed a tour of the ICE! It's a Charlie Brown Christmas production at the Gaylord Hotel in National Harbor, Maryland. The trips were made possible through grants awarded to Charities from Council Member Karen R. Toles (District 7) and the Prince George's County Local Development Council, respectively.

Middle School Mentoring: The Sarah Wise Wooten Young Ladies Academy is designed to cultivate young ladies attending middle school in Prince George's County by involving them in substantive activities that encourage positive self-imaging, develop leadership skills and promote positive community involvement and academic excellence thus producing high achieving, socially productive and responsible future leaders. Students began the year with a workshop highlighting the importance of bullying prevention. With social media applications such as Instagram and the constant communication exchange among adolescents, our youth are exposed to bullying and its consequences at an increasing rate. Students participated in a candid dialogue about bullying, its presence both online and in schools, as well as measures that can be taken to stand against bullying. In February, the students brought the rhythm and the noise to honor Black History Month with the dynamic world-renowned professional dance company, Step Afrika. The students received a brief introduction about Step Afrika with an explanation of the cultural origins of the art of stepping and the various forms of African traditional dances. Students explored the fashion, acting, and photography industries. From designing an article of clothing, performing an improvisational skit, to conducting a professional photo shoot, the participants were fully engaged from start to finish. Healthy eating habits and positive lifestyle choices were discussed in April as the girls learned to make healthy fruit and vegetable smoothies. The 5th Annual 2018 Tots To Teens Expo at the Prince George's Sports and Learning Complex as the venue for the May workshop. The annual expo serves the Washington region by connecting children and their families to local organizations and businesses where they participated in diversity, healthy lifestyles, STEAM and selfdefense activities. Fall workshps focused on STEAM as the young ladies used fragrance lab kits to create their own perfumes, participated in an interactive game of Math Jeopardy, and learned about computer coding and robotic art. The students ended the year by participating in community service project to make dresses from pillowcases to be sent to girls in Liberia.

High School - College and Career Preparation: The Institute for the Growth and Development of All of America's Youth (Institute GADAAY) promotes the personal, social and cultural growth and development of high school students – both males and females - to prepare them for college and careers. In partnership with the Iota Gamma Omega Chapter, Charities adopted the ASCEND program - Alpha Kappa Alpha Sorority, Inc.'s signature educational enrichment program – as part of its service for high school students that focuses on enhancing students' skills and abilities in STEAM activities, appreciation of Historically Black Colleges and Universities, and understanding of the United Nations and its global impact. As a result of a Department of Parks and Recreation grant, students participating in GADAAY, SWWYLA and the Cotillion~Beautillion were able to attend a special performance of the Alvin Ailey Dance Theatre at the Kennedy Center. As a community service project, the students made gingerbread houses over the holidays for sick children and wrapped more than 500 toys that were distributed to every student at Suitland Elementary School in collaboration with Council Member Karen R. Toles.

High School - College and Career Preparation: College Admissions Process (CAP!). Recognizing the escalating costs of college application fees, Charities hosted two special college day events where high school seniors were able to submit an application to the Common Black College Application at no charge. Students were also provided a trunk load of dormitory and class items. A total of 100 students benefited from the college admission process and the college awareness event.

High School - College and Career Preparation: Scholarships. Since 1994 Charities has provided more than \$600,000.00 in scholarships to Prince George's County students on the basis of academic excellence or financial need. Through our participation in the United Way of the National Capital Area's Do More 24 fundraising campaign, we were able to increase the minimum scholarship amount to \$1,500.00. In total, we awarded more than \$50,000.00 in scholarships to 29 students ranging from \$1,500.00 to \$3,000.00 in 2018.

Cotillion~Beautillion, The Cotillion~Beautillion is a formal ball where young ladies and young gentlemen are introduced to society. Charities previously conducted the event on an annual basis. Prior to 2008 the ball was conducted as the culminating event of the Institute GADAAY; after 2008, the event was held as a fundraiser. After the 2015 Cotillion~Beautillion, Charities conducted a thorough assessment of the feasibility of continuing the ball and the decision was made to hold the event in alternating years and tie it to our program efforts rather than as a fundraiser. This decision was based on an analysis of the 15-year trend of the revenue and expenses which revealed that the financial return on investment was below 35% in every instance. Thus 2018 was the first year of the event since 2015. The theme was "A Portrait of Elegance and Grace" and 16 students including 14 debutantes and two beaus were introduced to society at the event which was held at Martin's Crosswinds in Greenbelt, Maryland.

Addressing the Needs of Families

Parenting: The Parents on Track initiative provides workshops and resources for parents, who meet monthly during the same time that their students participate in our youth programs. The interactive sessions allow the parents to share their experiences, concerns and techniques, and to receive information from experts about critical issues that affect their families, thereby establishing a support network to empower them as agents of change.

The Elderly - The Sunshine Club. Every month Charities volunteers treat the residents of the Forestville Health and Rehabilitation Center to a day of pampering, fun games such as bingo with the chance to win prizes, and special birthday celebrations. In 2018 as the result of a grant from the Parks and Recreation Department of the Maryland National Capital Park and Planning Commission, Charities arranged for 16 residents and chaperones to take an Odyssey Cruise on the Potomac River that included a full lunch and entertainment. For nearly one year, a blind resident had been waiting to receive books on tape from another source. After learning of the man's request, Charities surprised him with a CD player and three books on CD for his listening pleasure.

Adopted Families. In partnership with the Maryland Department of Human Services for Prince George's County, Charities' Family Advocates supported six families by securing the resources necessary to achieve their family-specific goals. The families include 23 children, one grandparent-headed family, one foster parent-headed family, three single parent head of household families and one two—parent household. Activities during 2018 included providing shoes, seasonal wraps, school uniforms, financial literacy workshops, family outings such as barbecues, and Christmas gifts for the entire family.

Angel Tree Project. We continued our partnership with the Mall at Prince George's to support the children of incarcerated parents by providing holiday toys, clothing and other personal items. During 2018, Charities donated gifts to support 80 families.

Delivering Services - Shoe Bank. Since its inception, Charities has provided new shoes to students in need as identified by local school administrators, the Prince George's County Department of Social Services and area nonprofit organizations. In 2017 Charities was selected as BB&T Bank's Lighthouse Project for Prince George's County as a result of this service activity. In 2018, our targeted audience included our Adopted Families and Popcorn Club participants as well as students identified by school principals and staff.

Women's Health and Wellness. During the month of October, Charities hosted a Breast Cancer Awareness Symposium at the Ivy Youth and Family Center. Breast cancer survivors shared their stories with the audience and Keynote Speaker and Surgical Breast Specialist, Dr. Regina Hampton-Coleman, spoke to the group of 80 participants regarding early detection, screening, and treatment for breast cancer.











Sustaining Strategic Partnerships = Successful Service

Alpha Kappa Alpha Sorority, Inc. including Iota Gamma Omega Chapter, Upsilon Tau Omega Chapter's Southern Prince George's Community Charities, Inc., Psi Epsilon Omega Chapter's The Pearl Elegance Foundation, Eta Chapter/Bowie State University and Theta Nu Chapter/University of Maryland College Park – collaborated on a myriad of programs and service activities including Ivy League, ASCEND, and Martin Luther King, Jr. Day of Service initiatives.

Alpha Phi Alpha Fraternity, Inc. Kappa Epsilon Lambda and the KEL Educational Foundation continued to conduct their Alpha Academy, a mentoring program for middle and high school-aged males, at the Ivy Youth and Family Center. Approximately 50-60 young men attended the sessions which are held on the second and third Saturdays of the month.

23rd Annual 5K Walk for the Health of It - held at the Watkins Regional Park in Upper Marlboro, Maryland. More than 300 individuals and sponsors supported the effort which allowed us to provide financial assistance to the American Heart Association, Alzheimer's Association and National Association for Mental Illness.

Addressing the increased need to support child hunger efforts, we partnered with area food banks - **Bowie Interfaith Food Pantry, Bethel House, City of Praise** Food Bank, and the **Family Crisis Center**. Our volunteers provided nonperishable food, recipes and childhood hunger awareness information to approximately 4,000 families via pantry, school and direct support.

City of Praise Family Worship Center – site of the Ivy League Awards program held in June where we recognized all of our Ivy League participants and scholarship recipients.

Forestville Health and Rehabilitation Center - engaged the residents in games, birthday parties and other activities to stimulate their minds. Approximately 35 senior citizens interacted in social activities to keep their minds stimulated. As a result of a grant from the Maryland National Capital Park and Planning Commission's **Department of Parks and Recreation**, we held our second annual cruise down the Potomac River and lunch on The Odyssey ship!

The Mall at Prince George's – participated in the Mall's Annual *Angel Tree Project*, providing gifts to the children of incarcerated parents in collaboration with the *Prince George's County Jail Ministry*. Angel Tree gifts were donated to the Family Crisis Center and Popcorn Club participants who attended William Beanes Elementary School.

Charities launched its partnership with the *Prince George's Community College CASH* campaign in 2018. A total of 300 individuals participated in a co-sponsored financial literacy event, "*Money Explosion - A Financial Fair*," which targeted members of the community at all age levels.

Prince George's County Council Member Karen R. Toles - provided the opportunity to broaden our services through co-sponsorship of her Councilmanic District Seven Hop Into Health Easter Community Fun Day. More than 150 families received toiletries, nutritious snacks, and valuable information about resources available in the County while enjoying pony rides, train rides and great outdoor fun. With assistance from the members of Omega Psi Phi Fraternity, Inc. and Kappa Alpha Psi Fraternity, Inc. for a total of 68 volunteers, Charities hosted two Free Community Shred Days at Ardmore Elementary School in Springdale, Maryland under a grant from Council Member Toles. A total of 178 community residents brought their sensitive paper documents to be shredded or recycled. Our efforts helped to shred 7,620 pounds or 3.81 tons of paper! All of the paper shredded was 100% recycled and will be used to produce new paper products.

Prince George's County Department of Social Services and *Foster Parents of Prince George's County* - provided financial support for families in need. Charities supported six *Adopted Families* including 23 children with clothing, shoes, school supplies, backpacks and food throughout the year.

Prince George's County Public Schools - provided 340 backpacks filled with school supplies to students at area elementary, middle and high schools directly and as a partner at the County's Annual Stuff-a Bus initiative. We purchased arts supplies for Forest Heights Elementary School as well as Back to School gift bags for the teachers and staff. In response to a special request from the principal at William Beanes Elementary School, we provided 55 backpacks filled with all of the essential school supplies on the school's student list. We refreshed and renewed the playground at District Heights Elementary School and spruced up the grounds with new shrubs and plants with assistance from the members of Omega Psi Phi Fraternity, Inc. We purchased toys for every student at Suitland Elementary School as part of the Holiday Toys for Students event held in partnership with Council Member Karen R. Toles. In addition, rehearsals for the 2019 Cotillion~Beautillion were held at Hillcrest Heights Elementary School.

Seaton Empowering Action in the Community (SEAC, Inc.) – provided an annual scholarship for a student based on exemplary community service and continued our partnership with the "Once Upon a Gown Project" that provides prom gowns and accessories free of charge to students in need.

As a new Community Business Partner with **Wegman's Food Market**, we were able to provide approximately 600 food items for 100 families of four (a total of 400 people) in Monrovia, Liberia, West Africa. Food packages were shipped in October 2018 and expected to arrive in Liberia by Christmas 2018. Food packages can feed families of four individuations for up to ten days.



Charities employs a host of revenue generating streams to support its efforts including membership dues, fundraisers, grants, endowment funds, online campaigns and federal charitable campaigns. In 2018, Charities witnessed its highest fundraising income for its two primary fundraisers in 15 years as well as the most grant income in its 32-year history. As the value of the Ivy Youth and Family Center continues to increase as a result of the improvements that we have made as a result of Community Development Block Grant awards, our balance sheet demonstrates a steady upward trend that surpassed last year's status by \$150,000.00.
